





INSTALLATION INSTRUCTIONS

1. Beginning on the DR side, attach the mount brackets to the mount studs. **See Photo 1.**
2. Place DR brackets on the mount studs and hand tighten the 8mm flange nuts.
3. Using a 10mm socket or wrench, snug the (9 ea.) 8mm flange nuts on the mount studs. Do not fully tighten at this time. **See Photo 2.**



4. Align step to brackets and loosely install step using (6 ea.) 8mm x 28 bolts. **See Photo 3.**
5. Using a 10mm wrench, tighten the steps to mount brackets. **See Photo 4.**
6. Repeat steps 1-5 for PASS side.
