

Post-Transfer Eligibility & Previous Athletic Participation Form. Students transferring into a new TCSAAL member school, having participated in extracurricular competitions at their previous TCSAAL member school during the current academic year, are ineligible to participate in TCSAAL Contests starting with their first date of instruction at the new school, and ending 60 calendar days after their first date of instruction. Exceptions to this rule can be granted solely by TCSAAL Administration, potentially with the help of TCSAAL Advisory Board Members, and will be dependent on the successful submission and approval of the PAPF and its respective contents satisfying the burden of proving student-athlete's transfer satisfies TCSAAL policy prohibiting recruitment as determined by TCSAAL Administration.
