### What are Cookies?

Cookies are small text strings that a site sends to the user's terminal, where they are automatically stored and then automatically sent back to the site each time the user accesses it. Cookies enable the site to recognize the user's device and allow the user to navigate between pages, remembering preferences expressed and improving the user experience. They can also make sure that advertisements displayed online are more appropriate and relevant to users' interests.

- directly by the owner and/or manager of the platform (so-called first-party cookies);
- by third parties other than the publisher of the platform visited by the user (so-called third-party cookies). Unless otherwise specified, it is recalled that third-party cookies fall under the direct and exclusive responsibility of the same operator. Further information on privacy and their use can therefore be found directly on the platform of the respective operators.

Taking into account the indications of the Privacy Guarantor and the opinions issued in the European context by the Working Group ex art. 29 (independent European working group,

now replaced by the European Data Protection Board, so-called EDPB), Cookies can be traced to the following categories:

### **1. Technical Cookies**

Technical Cookies are necessary to carry out the transmission of a communication over an electronic communication network and for the provision of the service requested by the user.

They include:

- Session or navigation cookies: these are the cookies that are not stored persistently on the user's terminal and are deleted when the browser is closed and are strictly limited to the transmission of session identifiers necessary to enable the safe and efficient exploration of the site;
- Functionality Cookies: they allow to remember site settings chosen by users, such as language or privacy preferences, in order to improve the services and browsing experience.

With respect to these types of Cookies, it is not necessary to acquire the user's prior and informed consent.

### **2. Analytical Cookies**

Analytical Cookies, as recently remarked by the Data Protection Authority, can be used, among other things, to assess the effectiveness of an information society service provided by a publisher, for the design of a platform or to help measure its traffic (i.e. the number of visitors, including possibly broken down by geographic area, connection time slot or other characteristics).

Similarly, analytical Cookies, when installed by third parties, do not require the collection of prior consent from the user where direct identification of the data subject is not achieved (so-called single out) in order to prevent the use of direct and unique identifiers. In particular, such Cookies must have the following characteristics: (i) the same Cookie must be referable not only to one but to several devices, so as to create reasonable uncertainty about the computer identity of the person receiving it (e.g. through the masking of appropriate portions of the IP address), (ii) the use of Cookies shall be limited solely to the production of aggregate statistics and such Cookies may be used in relation to a single site or mobile application, so as not to allow tracking of the person's browsing using different applications or browsing different platforms. In addition, it is clarified that third parties, which provide the publisher with the web measurement service, shall not in any case combine the data, even so minimized, with other processing (customer files or statistics of visits to other sites, for example) or transmit them in turn to further third parties, under penalty of unacceptably increasing the risks of user identification; except in the case where the production of statistics by them with the minimized data affects several domains, platforms or apps that can be traced back to the same publisher or business group.

On the other hand, the user's consent will be required for analytical Cookies installed by third parties without guarantees aimed at minimizing the processing of data collected through the same Cookies.

### 3. Profiling Cookies

Profiling Cookies are used to trace specific actions or recurring behavioral patterns in the use of the offered functionalities (pattern) back to determined, identified or identifiable subjects in order to group the different profiles within homogeneous clusters of different widths, so that it is also possible to modulate the provision of the service in an increasingly personalized manner, as well as to send targeted advertising messages, i.e. in line with the preferences manifested by the user in the context of web browsing. The installation of Profiling Cookies and the resulting processing of your personal data are optional, so your consent is required for the installation of this type of Cookie.

Your consent will also be required in relation to "mixed" Cookies (i.e. installed and used for different purposes and which do not have a mere technical/analytics connotation).
