ANSUL Historic Foam Concentrates

Johnson Controls Fire Suppression Products has introduced several new ANSUL brand C6 firefighting foam concentrates over the past two years. These new, environmentally-mindful concentrate formulations contain short-chain, C-6 fluorochemicals manufactured using a telomer-based process. The telomer process produces no PFOS and these C-6 materials do not break down to yield PFOA. The fluorochemicals used in these concentrates meet the goals of the U.S. Environmental Protection Agency 2010/15 PFOA Stewardship Program.

To assist customers transitioning to the new C6 concentrates, the ANSUL products being displaced remained available for a period of time. These legacy products have now been phased out. The following products are now obsolete and no longer commercially available:
