## **MINUTES**

COUNCIL MEETING AUGUST 8, 2011 7:00 PM

Mayor Jerry Neace called the meeting to order. Council members present were Beverly Holcomb, Robert Bohannon, Jeff Parrish, and Rodney King. City Administrator Karen Degges, Waste Water Treatment Plant (WWTP) supervisor Chad Conard, and Police Chief Osborn were also present, as well as City Attorney David Syfan.

Mayor Neace led the Council in the Pledge and invocation.

Mayor Neace moved to Item 3: Consent Agenda. There were two items on the Consent Agenda – WWTP – Replacement of Influent Pump #1 and Minutes – December 28, 2010, July 25, 2011. Mayor Neace called for a motion to accept the Consent Agenda.

ACTION: Council member Bohannon made the motion to approve the replacement of Influent Pump #1 and adopt the minutes for December 28, 2010 and July 25, 1011. Council member Parrish seconded the motion. The motion passed unanimously.

Mayor Neace moved to Item 4 Citizens' Concerns. There were three items of Citizens' Concerns: Robert Cartee – Business License, Crystal & Derek Cook – Business License, and Harold Ansley – Water Bill.

Robert Cartee, 3540 Hwy 365, Alto, addressed the council. He explained he wanted to open Diamond Jewelry and Loan, an expansion of his California stores. The shop would deal with high end items, such as tools, cars, boat, jewelry, firearms, etc. Mr. Cartee said he had applied for his license to sell firearms in Georgia, but would not obtain it for two to three weeks. Council member Bohannon asked if an inspection of the building had been done. Ms. Degges explained Fire Chief Roy had inspected the building and found it to be fine, but City Inspector Joe Davidson's written approval had not been received yet. Mr. Syfan asked Mr. Cartee to reaffirm his intent was to operate a pawn shop and not an adult entertainment business. Steve Diamond, the business owner, stated his intent was not adult entertainment, but he would not rule that out. Mr. Syfan said the city recognizes adult entertainment has first amendment rights, but the city does have regulations for that business. A citizen asked Mr. Diamond if he would not rule adult entertainment out. Mr. Diamond stated he would not ever rule it out, but at this time, it would not happen. Valerie Rich, a citizen, said the BP Station beside the previous Wilder Outdoor store sold adult entertainment. Mr. Syfan again stated the city recognized the first amendment rights of adult entertainment. The city does regulate secondary effects. Mayor Neace called for a motion to accept the business license pending written approval from the building inspector.

ACTION: Council member Parrish made the motion to give Diamond Jewelry and Loan permission to obtain business license in Baldwin with the passing of the building inspection. Council member Bohannon seconded the motion. The motion carried a split decision with a 2-2 vote.

Next, Derek Cook, 118 Pine Forest Circle Apt F-3, addressed the council. Mr. Cook stated he had obtained written permission from Helena Dyer, manager of Pine Forest Apartments, to manage his business from his apartment. Mayor Jerry Neace called for a motion to approve Defense Kit, Derek Cook's business.

ACTION: Council member Holcomb made the motion to approve Defense Kit's business license. Council member King seconded the motion. The motion carried unanimously.

Harold Roy Ansley, 179 Harold Ansley Road, then came before the council. Mr. Ansley stated that he had no leaks. He did leave a small stream of water running for the cat, as he always did, but his water bill was very high. Mr. Conard stated that he, Junior Robinson, and Scott Gailey had personally checked the lines at the residence. Council member Bohannon added that either the meter was wrong or the water went through the meter. Mr. Conard said the meter was less than a year old, and had been checked. Mayor Jerry Neace asked for the meter to be checked two more times, Wednesday and Friday. The council decided, after the monitoring of the meter, to adjust Mr. Ansley's bill based on the formula using a six month average and the wholesale rates.

Mayor Jerry Neace asked for other citizen's concerns. Ray Holcomb, 600-A Baldwin Falls Road came before the council and stated that he felt yard sales had gotten out of hand. The ordinance says that citizens are allowed three yard sales a year, each no longer than three days long. He said some signs had been up continuously every weekend for the last six to seven weeks. Ms. Degges said there was no citation or penalty for violation of the ordinance. It would be the police department's responsibility to enforce the ordinance. Mayor Jerry Neace said the ordinance would need to be reviewed.

Mayor Jerry Neace then moved to Item 5: Old Business. There were four items of Old Business – Dollar General Parking Variance, Checking Account Consolidation, Signature Card for WWTP Grant Draws, and SPLOST Update.

Mayor Jerry Neace stated that Item 5(A) needed to be tabled because Dollar General could not be at the meeting.

ACTION: Council member Bohannon made the motion for Dollar General Parking Variance to be tabled until the next meeting. Council member Parrish seconded the motion. The motion carried unanimously.
