did then and there wilfully, unlawfully, feloniously and intentionally place another person in reasonable apprehension of immediate bodily harm and/or did willfully and unlawfully attempt to use physical force against another person, to-wit: CHRISTINE MACKINDAY, with use of a deadly weapon, to-wit: a knife, by holding said knife to the said CHRISTINE MACKINDAY'S head.

COUNT 7 - COERCION

did then and there wilfully, unlawfully, and feloniously use physical force, or the immediate threat of such force, against CHRISTINE MACKINDAY, with intent to compel her to do, or abstain from doing, an act which she had a right to do, or abstain from doing, by
