NARRATIVE
OFFICER NARRATIVE We were dispatched to the Sigma Alpha Epsilon (SAE) fraternity for an assault victim. I talked to the president of the fraternity, Logan Boggs. He advised that at about 0135 hrs, Nicholas Weisand was confronted by an uninvited guest at the party. Nicholas told him to leave the party after getting threats from the suspect. The suspect approached Nicholas as Nicholas turned away and struck him in the mouth with a right handed punch. Brandon McWayne intervened and was struck in the nose by another punch from the suspect. Other member of the party were able to get the suspect away from the two victims. The suspect then fled out the front door with two other unidentified black males. At the time of our arrival, Nicholas was already at Akron City Hospital. There was some blood in the living room. Logan advised that they had already cleaned up much of the blood. Photographs were taken of what remained. Brandon was still at the scene. There was noticeable swelling of his nose and he was worried that it may be broken. Logan was able to get a first name of the suspect through other members of the party after the incident. The suspect first name was Gabriel. Brandon was taken to Akron City Hospital by cruiser. He was admitted into the emergency room. Nicholas was already at Akron City Hospital at the time of our arrival. Nicholas did write a statement. He explained that the suspect, whom he called Gabriel was threatening him at the party. He did not understand what the threats were about and told Gabriel that he should leave the house. Gabriel then approached Nicholas as he was turning away. Nicholas felt a punch to mouth and fell to the floor. He was not sure what occurred afterwards during a scuffle but he advised that Gabriel fled out the front door with two other unknown black males. Nicholas had extensive damage to his mouth which included two front portion teeth that were completely knocked out. The teeth were still in his possession and on the counter of the emergency room. The two dislodged teeth included the roots as well. Photographs were taken of his injuries and the dislodged teeth. Todd Chance, was in the same emergency room as Nicholas, though he is only an acquaintance of Gabriel, he was able to provide a full name of Gabriel Dorsey. He also provided a photograph of Gabriel Dorsey that is associated with Dorsey's Twitter account. Todd was able to get a cell phone number for the suspect. Samantha Thompson, Nicholas' girlfriend, was also at the hospital and did write a statement about the events. She said that the suspect was threatening Nicholas but did not know what led up to the assault. She said that the suspect punched Nicholas in the mouth causing him to fall to the ground. She is not sure of the events after that because her concern was for Nicholas at that point. Nicholas advised that he wanted Gabriel prosecuted. Brandon was unsure if he wanted to prosecute. Officer Krantz went to the Akron Muni Clerks Office to sign warrants for Felonious Assault and afterwards University of Akron Dispatch entered the warrant. At approximately 0505 hrs, Officer Krantz was able to contact Gabriel Dorsey on his cell phone. He did acknowledge that he was at the Sigma Alpha Epsilon fraternity and was involved in an altercation. He was asked to come to our station for an interview. He said that he was in Copley and that he would come to our station as soon as possible. At approximately 0545 hrs, Gabriel arraigned at our station. He was notified of the warrant for his arrest and read his Miranda rights. Gabriel said that he understood his miranda warnings and agreed to talk to Officer Krantz and I. He was asked if he had any injuries and he advised that he was struck several times. There was no visible injuries on Gabriel except to his right hand. His right hand was swollen and had a small abrasion to his middle knuckle. He admitted the injury was the result of punching Nicholas in the mouth. He advised that the altercation began when Nicholas was pushing a female who was unknown to Gabriel. Gabriel claimed that he was coming to the females defense. He said that Nicholas kept pushing the female and that is why Gabriel went after Nicholas. He claims that members of the party attacked with numerous punches and tried to hold him to the ground. Gabriel said that he struggled to get to Nicholas and then managed to punch him in the mouth. After the altercation, Gabriel fled with a Dennis Haggins out the front door. Gabriel could not provide personal information for Dennis. Gabriel said that Dennis was the only one that he was with at the party. Dennis was not involved according to Gabriel. Gabriel was arrested at this point and transported to the Summit County Jail for booking. While at booking, Gabriel had a blood spatter tee-shirt beneath his sweat shirt. There were no obvious cuts on Gabriel and no visible injuries. The shirt was taken into evidence and placed in locker 3.

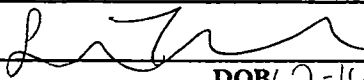
