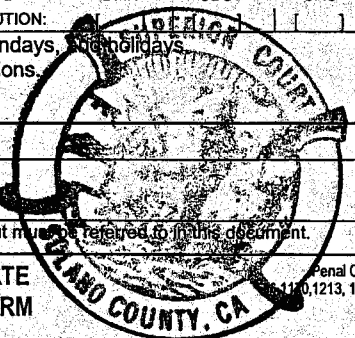

COUNT I


