1. Christian Titman will be permitted to do the following at the Clovis High School graduation ceremony, scheduled to occur on June 4, 2015: (a) wear the agreed upon prepared eagle feather (as reflected in the photograph attached hereto) in his hair during the graduation ceremony; and (b) upon receipt of his diploma during the graduation ceremony, is permitted to adorn his graduation cap with the agreed upon eagle feather, and to participate in the tassel turn with the eagle feather connected to his tassel, and may continue to wear the feather thereafter.

2. Agreed upon statement that Clovis Unified School District will issue: "The Clovis Unified School District remains committed to its long tradition of decorum at its graduation ceremony, including its dress code and its intended reflection of unity of the graduating class. At the same time, the District also continues to remain committed to its practice of working with students and their families when requests for accommodations or exemptions from the graduation ceremony dress code for sincerely held religious beliefs."

3. Plaintiff and District Associate Superintendent of School Leadership, Norm Anderson, agree to meet following the graduation ceremony to discuss ways to improve communication regarding graduation dress code accommodations for sincerely held religious beliefs and process for resolving such requested accommodations.


