



SUPPLEMENTAL CONTRACT

It is agreed by and between, **Megan Batykefer** (hereinafter "Employee"), and the North Allegheny School Board (hereinafter "Board"), Allegheny County, Pennsylvania, that said Employee, under the authority of said Board and its successors and subject to the supervision and authority of the Superintendent of the North Allegheny School District, shall serve as **Head Rowing Coach (M)** in accordance with the job description established for the Supplemental Contract term, **Spring 2013**.

Compensation shall be in accordance with the compensation schedule for supplemental contract positions approved by the Board for each school year and shall be payable upon successful termination of the activity each year, including completion of final activity and payroll reports. For **Spring 2013**, the applicable compensation for the supplemental contract shall be **\$2,000.00**. Payment will be made less applicable taxes and withholdings.

Employee acknowledges receipt and understanding of the supplemental position responsibilities and agrees to fulfill each requirement to the best of his or her abilities. It is further understood and agreed that the number of hours and scheduling of hours in fulfillment of the supplemental position responsibilities shall be at the sole discretion of the Board and, further, that this Supplemental Contract shall not be subject to tenure requirements or any contract of employment pertaining to tenure pursuant to the Pennsylvania Public School Code of 1949, as amended.

Employee understands and agrees that the Board, at its sole discretion, may decide to renew or not to renew this contract with Employee on an annual basis. In the event of a renewal, Employee shall be advised of the renewal and the position to which the employee was assigned, and, in such event, this Supplemental Contract shall remain in force. Employee further understands that the Board reserves the right to make assignments to supplemental contract positions at its sole discretion or to make no assignment to a supplemental position.

After June 30, 2013, the terms of this contract are null and void unless renewed as set forth above.
