~~(S)~~ During the course of the interview, Mobley repeatedly expressed concern for his wife and revealed that they had a pre-established plan she was to execute in the event of his arrest or disappearance. One aspect of this plan was his wife was to go to the Embassy immediately. Mobley did not indicate why he thought such precautions were necessary. Mobley was not surprised when notified his wife had come to the embassy after his arrest. Mobley repeatedly instructed [REDACTED] to tell his wife that he ordered her to leave the country with the children and return to the US. When asked to provide a phone number for his wife, Mobley claimed he could not remember.

Mobley initially requested that [redacted] but changed his mind when asked to provide her phone number. During the interview Mobley wrote down two notes, one which he asked be given to his mother and the other to his wife.

(U) ~~(S)~~ Finally, Mobley claimed he was shot under the following circumstances: On Wednesday, Mobley left his residence to obtain milk and oatmeal. After buying milk at a first store, Mobley tried to find oatmeal at a second store. After failing to find it at the second store, Mobley decided to return home. As he approached his residence, two white vans pulled up beside him and about 10 men, some wearing ski masks, jumped out. Certain of these individuals attempted to grab him and after he turned from their grasp and twisted out of his jacket, he was shot in the leg. He was then thrown into one of the vehicles, called a dog, and was hit on his head when he asked to speak to someone from the US Embassy. [redacted]
