Officer Notes:

On 8-9-2012 at approximately 2159 hours, Ofc Dawson and I were traveling Northbound on N. College in the center traffic lane when I noticed the vehicle in front of me, a white colored Lexus ES300, drift onto the white striped lane markings and then drift back into the center lane, traveling below the posted speed limit. As we approached the Joyce Blvd intersection, the vehicle began to cross into the left lane, but did so at an angle, occupying 2 lanes, and did so without signaling. The vehicle continued to travel into the turn lane without signaling. When the traffic signal turned green, the vehicle began to turn westbound onto Joyce from N. College, still not using a turn signal. I initiated a traffic stop on the vehicle at 4007 N. Shiloh. I made contact with the driver, Herbert Rule, who was verbally unwilling to cooperate with my instructions. I smelled the odor of intoxicating beverages coming from his person and from the vehicle. I initiated Standardized Field Sobriety Testing with Rule and after explaining and demonstrating all portions of each test, Rule completed the tests in a manner consistent with that of an intoxicated person. Rule was placed under arrest for DWI and transported to WCSO for BAC testing where he refused to sign any paperwork and refused to submit to a BAC test. Rule was charged with improper lane use, failure to use signal device, DWI, and violation of the implied consent law.
