**\*Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer of individuals whose contributions exceed \$200 in an election cycle**

Individuals are permitted to contribute \$ 2,600 per election. The 2013 Special Primary and General elections are each a separate election (total \$ 5,200). Multi-candidate political committees are permitted to contribute \$ 5,000 per election (total \$ 10,000).

Federal law prohibits contributions from corporations, labor organizations and national banks; from any person contributing another person's funds; from foreign nationals who lack permanent resident status; and from federal government contractors. **Contributions or gifts to Elizabeth Colbert Busch for Congress are not tax deductible.**
