Proposed Core Elements of Refreshed Policy (draft for discussion)

A. Use of Hounds on the NFE

On balance we considered this to be inappropriate in future on the grounds of H&S, animal welfare and uncontrollable impact on other wildlife.

B. Targeted Fox Control by FLS staff & contractors

The general control of fox populations has been shown to be ineffective, therefore targeted control would best be done under two circumstances:

- i) In response to neighbour complaints local/immediate response where significant damage can be demonstrated
- ii) Planned proactive control in known sites where repeated damage occurs e.g. sensitive conservation areas, adjacent to neighbour damage 'hot-spots'

(both timed to short window in late winter/early spring to minimise animal welfare issues and maximise effectiveness)

Proposed Next Steps

- 1. Redraft relevant sections of the current policy to reflect the proposed refreshed approach.
- 2. Set out the evidence and details that will form the content of a supporting document.

Incl. sections or summaries of:

- a) Additional references relating to legal, regulatory and best practice aspects
- b) Summary details of existing legal rights held by other parties
- c) Risks, constraints and hazards associated with FLS fox control activities (incl. insurance requirements required by 3rd parties should they undertake Fox control on the NFE)
- 3. Consult others on the redraft and to resolve key questions such as -
 - Establishing a clear evidenced rationale for not allowing the use of hounds.
 - Clarifying the circumstances under which FLS would carry out pre-emptive or responsive fox control
 - Clarifying our position on fox control activities by other parties as part of Recreational DMP's.
- 4. Suggested stages for consultation

Stage 1 – key FLS staff (lan, Doug, Kenny, Jo, Me, Trefor)

Stage 2 - wider group of FLS staff (RM's DM's, EnvA's, WRM's)

Stage 3 – consider requirement for consultation with external groups (SNH, SGA, etc..)
