On Friday October 11, 2013 at approximately 1242 hours while in plain clothes I walked through the parking lot referred to as the "Circle Lut" located within the Liduewater Park, Lakefront Reservation, Cleveland, Ohio, Cuyahoga County.

I observed James R. Milliamegal enter the parking lot driving a black Jeep'sport utility vehicle bearing Ohio plate FHJ2874. McGonegal made eye contact with me as I walked through the parking lot. I exited the parking lot and began to walk the trait differ to the east of the parking lot. McGonegal parked his vehicle in the closest possible parking space to the trail head where I had just begun to walk. After walking approximately fifty feet on the trail I stopped and looked back to see McGoneyal had rolled his driver side front window down. McGonegal was tapping on the door frame and walving at me. I walved back at McGonegal and continued to walk the trail away from McGonegal. After approximately two minutes of walking I could no longer see McGonegal or the parking lot. I stopped, waited approximately two more minutes and began to walk back towards the parking lot.

As I walked back towards the parking lot I observed McGonegal backing out of his parking spot. McGonegal saw me walking back towards the parking lot, and pulled back into his parking space. As I made my way closer to the parking lot I could see McGonegal was continuing to look at me. Upon reaching the parking lot I began to walk by McGonegal's vehicle. McGonegal then engaged me in conversation, asking what I was doing. I told McGonegal I was just walking, and enjoying the nice weather. I asked McGonegal what he was up to. McGonegal responded by saying he was "cruising" (which is a common term used to mean he was actively looking for a person to engage in sexual relations with).

As I spoke with McGonegal I could see he was actively rubbing his genitals with his hand over his pants. As I observed McGonegal to be doing this he smiled at me. I asked McGonegal if he wanted to get out and go for a walk. McGonegal stated he didn't want to get out, and that he knew people that had been "busted" by the rangers in the park before. McGonegal asked if I wanted to get in his vehicle. I advised McGonegal that I didn't like to get into other people's vehicles. McGonegal stated he would give me a ride to my vehicle, which I told him was parked in the upper parking lot. McGonegal then suggested I could follow him to his home, stating he lived nearby. McGonegal asked me what I was into, and I told him I was into "everything, just like everybody else". I then asked McGonegal what he was into and he said he was "looking to get off." McGonegal then asked me if I "was looking for money." I advised McGonegal that I was. McGonegal then asked me how much money I wanted. I told McGonegal I did not know, and asked him what he wanted. McGonegal responded, saying he wanted "to get off" and "would pay [me] fifty dollars to get [him] off." I told McGonegal that would be okay. I then asked McGonegal "what exactly do you want, a blow job or a hand job?" McGonegal replied that he just wanted to get off. I then asked McGonegal if he was a cop. McGonegal stated he was not. I told him I was not sure and asked him to "see it." McGonegal then proceeded to unzip his pants. He removed his penis from his underpants, showed me his penis and began to masturbate. I then informed McGonegal that I was a park ranger and that he was under arrest.

At the time McGonegal exposed himself to me and began to masturbate there were other people in the immediate area, both in cars and on foot. I had McGonegal exit the vehicle, turning over his identification and car keys to me. McGonegal did so cooperatively. I then had McGonegal wait in the center of the parking lot until a marked patrol car could arrive.

Moments later Sergeant Sylvis and Ranger Thirion arrived on scene. Shortly after their arrival Ranger Peairs arrived on scene. McGonegal was placed in handcuffs and searched. He was then placed in the back seat of Ranger Peairs' patrol vehicle. While in the back of Ranger Peairs' vehicle, McGonegal advised me he was HIV positive.

While conducting a tow inventory of McGonegal's vehicle three sexual devices, commonly referred to as "cock rings," were located. One of these rings was wrapped around the lid to a bottle labeled "Pig Sweat." The bottle

logo was of a pig/man figure wearing buttocks-free chaps. Below the name on the bottle was writing stating the product was nail polish remover. The labeling also indicated that the product contained isobutyl nitrite, a harmful intoxicant.

I returned to Ranger Peairs' vehicle and informed McGonegal of his Miranda rights, which he stated he understood and waived. I asked McGonegal about the "Pig Sweat." McGonegal stated he got it from a sex shop and he would smell the product and doing so gave him "a buzz."

McGonegal was transported to Cleveland Jail without incident by Ranger Peairs and myself. While at Cleveland Jail, McGonegal advised jail personell he was HIV positive. Before leaving the jail, Ranger Peairs also read McGonegal his Miranda rights and asked him about his HIV status. McGonegal again advised Ranger Peairs he was HIV positive.
