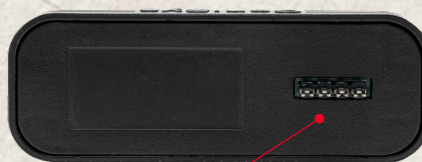

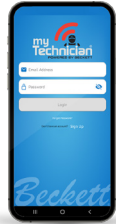
1. SCAN

- Follow links to either the Apple App Store or Google PlayStore.



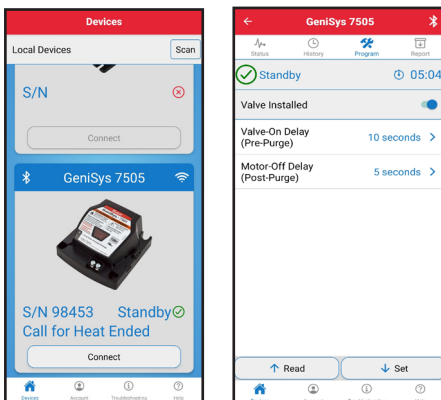
2. DOWNLOAD

- Download the myTechnician™ app.
- Create an account with username and password.
- Check your e-mail to complete the registration.



3. PROGRAM

- Open and login to the myTechnician™ app.
- Follow the process seen on the screens below.



4. Additional App Features

- Real-time burner status of voltage, current, ohms, time to light, last end cause.
- Troubleshooting.
- History of the last 15 cycles.
- History of faults if within the last 15 cycles.
- Lifetime cycles and runtime.
- Share report via email in PDF format of control history, technician, appliance, burner information, images and service notes.
