Installation Instructions

Model 2000 (threaded connections) two-way flow check can be used for angle or horizontal installation. See below. When used horizontally, the bottom connection can be used as a bypass connection or plugged. **THE FLOW CHECK IS SUPPLIED IN AN OPERATING POSITION** (See Figure A). To change to an open position, turn the adjustment knob counterclockwise (See Figure B). **Model 2000S** (sweat copper connections) is for **HORIZONTAL INSTALLATION ONLY**.

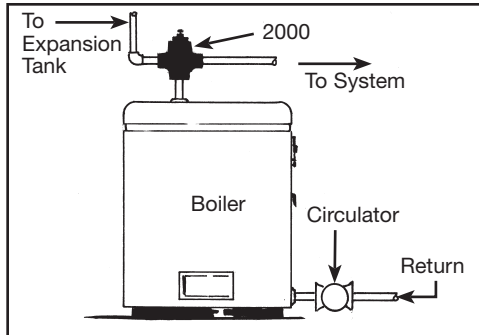

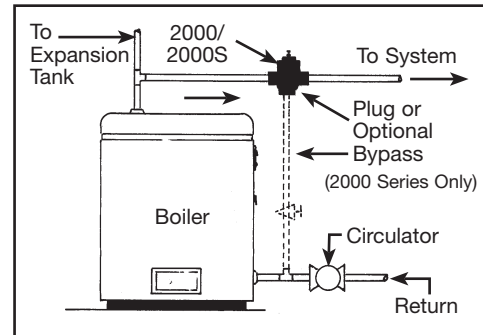
IMPORTANT! Flow must always be in direction of arrow on valve body.

Angle Installation



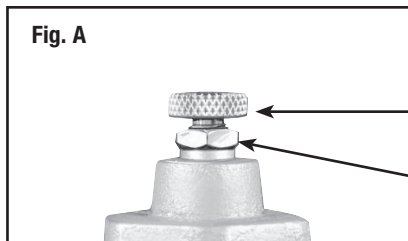
Flow Check is supplied in a Normal Operating Position

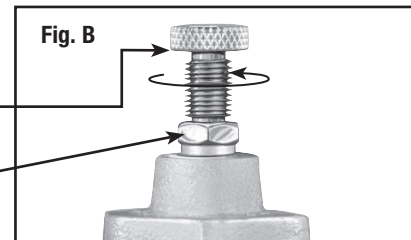
