## KRISPY KREME DOUGHNUTS FOR LIFE GIVEAWAY (360 DOZEN DOUGHNUTS)

## OFFICIAL SWEEPSTAKES RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

- 1. **ELIGIBILITY:** The Krispy Kreme® Doughnuts for Life Giveaway (the "Sweepstakes") is open only to legal residents of the 50 United States and the District of Columbia, who are 18 or older at time of entry, and who have a Twitter, Facebook, Vine or Instagram account. Only individuals may enter; groups, organizations and multiple-party entries are not eligible. Void where prohibited or restricted by law. Subject to all applicable federal, state, and local laws and regulations.   - a. Take a "selfie" that includes you and your favorite superhero either at a Krispy Kreme location or prominently featuring a Krispy Kreme product (the "Entry Photo").

You understand that by submitting an Entry, you are accepting the terms of these Official Rules and are agreeing to be bound by them.
