#### LEGAL DESCRIPTION - Doc. # 205013588

Lot Number 13 in Pine Lane Addition, being a subdivision of the East 376 feet of the West 566 feet of the South 815 feet of the Southwest 1/4 of the Northwest 1/4 of Section 28 in Township 31 North, Range 13 East, according to the plat thereof, recorded in Plat Record 21, page 14, and re-recorded in Plat Book 27, page 85, more commonly known as 4821 Trier Road, Fort Wayne, Indiana 46815.

#### SURVEYOR'S REPORT

This report and the accompanying survey plat have been prepared in accordance with Title 865, Article 1, Rule 12, Sec 1-29 and all amendments thereto of the Indiana Administrative Code, which establishes the minimum standards for the practice of land surveying.

Monuments set are 5/8 inch round by 24 inch long steel rebars with yellow plastic caps stamped "GOU LS29500017", and set flush with the ground surface.

Monuments found are noted with an above (x.x) or below (-x.x) ground surface dimension.

This purpose for this survey is to "retrace" the boundary of the real estate described hereon.

#### THEORY OF LOCATION:

The lines and corners for this survey were established as depicted on the survey drawing and per information shown on the plat of Pine Lane Addition.

The uncertainty in the lines and corners found or established by this survey are as follows:

- (A) Availability and condition of reference monuments:
  - Monuments found are described and depicted on the survey drawing.
  - Uncertainty created by the location of the monuments found or set on the subject property due to variations in reference monuments (monuments found on the subject property and on adjacent properties) is the difference between "measured" and "platted" or "recorded" angular or distance measurements as depicted on the survey drawing. The maximum uncertainty for this survey is 0.18 feet.
- (B) Occupation or possession lines:
  - No uncertainty was created by visible occupation or possession lines.
- (C) Clarity or ambiguity of the record description and or adjoiner's descriptions: No uncertainty was created by the above mentioned documents.
- (D) This survey falls under the classification of a "Suburban" survey. The acceptable relative positional precision (random errors in measurements) = 0.13 feet (40 millimeters) plus 100 parts per million as specified in Section 7 of said Rule 12.
