 - h. Deliberation by the Board of Education
4. Vote to acknowledge Board of Education's return to Open Session and testament that no votes were taken.
5. Vote to adopt findings of fact on the suspension of Student No. 1.
6. Vote to affirm suspension, modify suspension or overturn suspension of student 1.
7. Vote to Adjourn
