Parental Family Engagement Policy

Vian Public School agrees to implement the following statutory requirements:

- The school district will put into operation programs, activities and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of participating children.
- Consistent with Section 1118, the school district will work with its schools to ensure that the required school-level parental involvement policies meet the requirements of section 1118(b) of the ESEA, and each include, as a component, a school-parent compact consistent with Section 1118(d) of the ESEA.

Parental involvement means the participation of parents in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring—

- (A) that parents play an integral role in assisting their child's learning;

- (C) that parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child;
- (D) the carrying out of other activities, such as those described in Section 1118 of the ESEA.

Implementation:

1. Vian Public School will take the following actions to involve parents in the joint development of its districtwide parental involvement plan under Section 1112 of the ESEA:

Invite parents to participate in the Title I planning meeting(s).

2. Vian Public School will take the following actions to involve parents in the process of school review and improvement under Section 1116 of the ESEA:

Invite parents to meetings to review the Title I, Part A schools and ask for recommendation for improvement.

3. Vian Public School will provide the following necessary coordination, technical assistance, and other support to assist Title I, Part A schools in planning and implementing effective parental involvement activities to improve student academic achievement and school performance:

Open House, Parent/Teacher Conferences, Title I, Part A planning meetings.

4. Vian Public School coordinate and integrate parental involvement strategies in Title I, Part A with parental involvement strategies under the following other programs:

Head Start and local day care

5. Vian Public School will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A schools. C.
