# REPORTS

#### 1. Curriculum Management Plan

Mr. Browning shared with the Board the Curriculum Management Plan that will serve as the framework for instruction and student assessment. The plan will direct all curriculum components toward alignment with the TEKS and/or other state and national standards. This plan is designed around the components of written, taught, and tested curriculum to provide each and every student with a meaningful, challenging education.

#### 2. Data Driven Instruction (DDI) Site Resources

Mr. Browning shared with the Board that the Data-Driven Instruction Guidance planning was available online for teachers to use in planning their lessons for the year.

# 3. Kindergarten Standard-Based Report Card

Mrs. Gatlin and Mrs. Holland shared with the Board the new Standard-Based Report Card. This will allow the parents to see if their student has Mastered skills that have been taught or if they are Approaching Mastery, Beginning Progress towards standard or if they have areas of concern in which they need additional help. This allows the parent, student and teacher to know a student's exact academic strengths and weaknesses.

# 4. Advanced Academic Curriculum

Mrs. Routon shared with the Board that the District has purchased "SpringBoard Curriculum," which goes along with the CollegeBoard Curriculum for English and Math as a more rigorous curriculum for the advanced students.
