REPORTS:

Campus Reports

Mr. Gordy, Principal Graham High School shared with the Board that the High School is working towards High Reliability Schools, Level 2 Certification. The Student Activity Leadership Team (SALT) is a student lead organization made up of students from the different clubs, organizations, and athletics. One of their main goals is to develop more school spirit.

Mrs. Ginger Robbins, Principal Graham Junior High School shared with the Board that the current enrollment is 549, 58% of students are on free & reduced breakfast and lunch. 52% of the students are in Special Programs; 504, ESL, Sp. Ed, Dyslexic, English Learners, Hearing Impaired and Speech. Electives Offered this year are Art, Band, Computer Apps, Drama, Journalism, Multimedia, PLTW, Boys and Girls Athletics and Tennis. Accelerated Courses include Advanced Language Arts, Advanced Math, Advanced Science and Advanced Social Students. Clubs and Organizations on the campus include Builders' Club, Character Ed Officers, Destination Imagination, Future City, NJHS, News Crew, Science Research Team and Student Council.

Lisa Budarf, Principal Woodland Elementary shared with the Board that the current enrollment is 399, 66% of the students are on free & reduced breakfast and lunch. 60% of the students are in Special Programs; 504, Dyslexic, ESL and Sp. Ed.

Amanda Townley, Principal Crestview Elementary shared with the Board that the current enrollment is 528, 61% of the students are on free & reduced breakfast and lunch. 41% of the students are in Special Programs; 504, Dyslexic, Gifted/Talented, Bilingual, ESL, Speech and Sp. Ed. The Accountability Rating for 2017-2018 = Met Standard.

Donna Gatlin, Principal Pioneer Elementary updated the Board on the new teacher training that has taken place for the 5 new teachers. They have been trained in Readwell, Math online textbook training and Conscious Discipline Training.

GISD Teacher Mentor Program

Mr. Gary Browning is working with retired Graham ISD teachers to Mentor our new teachers.

DISCUSSION ITEMS

2018 Campus/District Accountability Ratings

Mr. Gary Browning shared with the Board that Region 9 has provided Graham ISD a copy of the 2018 Accountability Summaries for the districts and individual campuses. Information is included that depicts the district, region, and state comparison on the various tests. Mr. Browning pointed out several areas where Graham had improved, and addressed the areas that the campuses will be focusing on this year.

Policy EIC (LOCAL) – Academic Achievement/Class Rank

The Board discussed the current policy on how Graham ISD calculates class rank vs how other school districts are calculated. The Board was in agreement, that if any changes were to be made it would be wise to do so for a cohort that has yet to enter the 9th grade. Any other cohort of students have already made course selections, etc. based on the rules in place when they entered high school. The Board would like to see more information from Highland Park ISD.

Food Pantry Discussion

A letter was received from a Graham Citizen regarding a food pantry program being implemented in some Texas school districts. Mr. Cruse shared that our Food Service Director, Jodi Aripse, has implemented a “share pan” program. Students can place any unwanted items in the pan and any student can pick any “extra” from the pan free of charge. Items not taken can be returned to the reserve supply for another time.
