Optional 1-to-1 Device Damage Protection Plan

For each school year, the Webster Parish School Board (WPSB) offers an Optional 1-to-1 Device Damage Protection Plan for all students in the 1-to-1 Device Program. Parents or guardians who do not wish to participate in the Optional 1-to-1 Device Damage Protection Plan **WILL BE RESPONSIBLE FOR THE COST OF REPAIRS AND REPLACEMENTS** throughout the school year.

It is strongly recommended that all students in the 1-to-1 Device Program elect to also participate in the Optional 1-to-1 Device Damage Protection Plan. Detailed information concerning what the Device Protection Plan covers, and does not cover, can be found below.

Information About The Optional 1-to-1 Device Damage Protection Plan

- ❖ The Optional 1-to-1 Device Damage Protection Plan is due at registration, is non-refundable and expires at the end of the current school year. The Optional 1-to-1 Device Damage Protection Plan allows for one repair of the deployed 1-to-1 Device, at no costs to the student or parent/guardian, as a result of an eligible incident. The Optional 1-to-1 Device Damage Protection Plan is limited to one repair, per Device, per school year. If you participate in the plan, the coverage is assigned to a specific 1-to-1 Device and accessories that are assigned to a student through the 1-to-1 program. An eligible incident is an incident that results in a need to repair or replace the Device in order to keep the Device operational, and which is the result of the student's accidental misuse of the Device.
- ❖ To continue coverage after an eligible incident, students and parents or guardians will have the option to reenroll in the plan to elect to continue to participate in the Optional 1-to-1 Device Damage Protection Plan on a repaired or replaced Device for the remainder of the current school year.
- ❖ If a student in the 1-to-1 Device Program does not elect to participate in the Optional 1-to-1 Device Damage Protection Plan and decides that they would like to after a Device and accessories have already been assigned, they will be able to do so only after a thorough review of the Device and all accessories takes place to verify it is in good shape and eligible to be added to a plan.
- ❖ Tampering with and/or taking a Device apart will void all coverage from the Optional 1-to-1 Device Damage Protection Plan. Report problems with your Device immediately to a teacher and/or school contact. Maintenance and repairs will be done by district technicians. WPSB will assess the Device damage and repair or replace the Device if the damage is determined to be accidental and within the protection guidelines. WPSB will use spare units or parts to replace or repair damaged or malfunctioning Devices. If the Device is broken or damaged without payment of the Optional Damage Protection Plan, the student may be left without a Device until the repair or replacement cost is paid. Do not take district-owned Devices to outside device service centers for any type of repairs or maintenance. Do not attempt to alter, repair, or open the Device yourself.
- ❖ The Optional Damage Protection Plan does not include intentional abuse of the Device.
- ❖ The Optional Damage Protection Plan does not cover cosmetic damage.



- ❖ The Optional Damage Protection Plan does not cover lost or stolen Devices or accessories and a police report must be filed.
