Reading Sufficiency-

We currently utilize the Acadience and STAR testing to determine if a child needs to be placed on a reading sufficiency plan. They are screened 3 times per year: Beginning of year, before Christmas in December and at then towards the end of May. Our goal is to have everyone on grade level by the time they complete 3rd grade and have to take the 3rd grade test.

We utilize the testing information from the test to determine specific learning needs for each individual. We purchased and are currently utilizing Reading Plus in grades 3-6 consistently. The teachers are seeing growth in readers. All of the mentioned forms of screenings, can help us make decisions on whether a student is reaching their goal, if they need to be further tested, if they need to repeat a grade, etc.
