

## **Wheeler School Advisory Council Minutes**

1. **Call Meeting to Order and Welcome to the Wheelers School Advisory Council** was made by Mr. Bailey at 1:15 p.m. in the Board Room.
2. **Introduction of Members-** Mr. Bailey introduced each committee member and welcomed the place for any new members. Members included Camden Dorris, Yuri Sotos, Heather Hardcastle, Danielle Jones, Judy Woollard, Randi Barr, Dahlia Venzor, JJ Houska, Sandy Rose, and Justin James. Members Angie Ware and Ashley Koeopke were unable to attend the meeting.
3. **Review of the Responsibilities and Purpose of the Wheeler School Advisory Committee-** Expectations and responsibilities of the Council were discussed. This Council was a combination of the Site Base and S.H.A.C. committees.
4. **Present 21-22 Comprehensive Needs Assessment (C.N.A.)Documentation-** Comprehensive Needs Assessment for 21-22 was distributed and previewed to help each member prepare for a discussion on the 22-23 C.N.A. that will be started at the next meeting.
5. **Overview of Food Services-** Randi Barr went over new requirements and activities in the lunchroom.
6. **Overview of School Health & Safety Issues**
  - a. **Bullying Policy-** The School Bullying Policy was reviewed and approved by the W.S.A.C., with Camden Dorris making a motion to approve the policy and Judy Woollard Second. All Members voted unanimously to accept the Bullying Policy.
  - b. **Wellness Policy-** The Council discussed and answered questions for the Triennial Wellness Policy Assessment. This assessment will be given to the Superintendent to bring before the School Board. Due to concerns about two significant highways' safety issues, Mr. Bailey went over a letter to request a waiver to participate in the school summer meal program. The request for a waiver was motioned by Judy Woollard and Seconded by JJ Houska to be approved, with all members voting unanimously in agreement.

- c. **Sex Education Curriculum-** Camden Dorris informed the Council that the Sex education curriculum was aligned with the T.E.K.S. and tied in with the curriculum material adopted by the school. He also spoke about the P.A.P.A. curriculum that he uses in Health Class that covers what it is like to be a Parent. Material for 5<sup>th</sup> & 6<sup>th</sup> grade Puberty awareness was also presented to the Council. The Sex Education and Puberty Curriculum was approved by the Council and presented to the School Board for their approval.
- 7. **Discuss School Technology-** Mr. Bailey discussed the purchase of new laptops for the Teachers and H.S. Students.
