Question and Answer for Thacker / Davis

- 1. Is the storm shelter required by law? We have options not necessarily required depends on version of building code we choose to use.
- 2. Do we need a Spring or Fall Bond? Architect provided a timeline handout for both.
- 3. How long would it take for you to put a proposal together? Around 2 ½ to 3 months. We would evaluate all campus needs, visit with teachers, admin, custodial, maintenance and listen to suggestions.
- 4. How would we budget for your compensation? Develop a contract and bill hourly but not to exceed a certain amount. If Harleton ISD goes with us to push bond and it passes we would credit this amount toward construction costs.
- 5. Could you estimate a cost for us? Not to exceed \$10,000 to \$12,000.
- 6. Do you have in house consultants? Yes we do and if not we use outside consultants for some things such as acoustical, security and food service.
- **7.** Did you build Ore City's newest facility? No, the last thing we built for Ore City was the Stadium and Gym.
