

PROCEEDINGS OF THE EVANGELINE PARISH SCHOOL BOARD

Ville Platte, Louisiana

August 7, 2019

Members of the Evangeline Parish School Board met this day in a regular scheduled meeting at 6:00 P.M. at the Media Center, 607 Harvey LeBas Drive, Ville Platte, Louisiana.

Board President Wayne Dardeau declared a quorum and ordered members to proceed with the business of the day at 6:00 p.m.

Ms. Wanda Skinner and Mr. Ellis Guillory entered the meeting at 6:03 p.m.

Item # 2 – Special Education Director Kelli Lafleur announced two EPSB District employees were recognized for their passion and commitment shown for the young people they serve in the jobs for America's Graduates Program. Both JAG Specialists successfully completed an on-site compliance monitoring of the JAG-LA programs, from the National Accreditation Team, during their year of transition, with no findings.

On July 7th – 12th in Orlando, Florida at the 36th Annual National Training Seminar both specialists gathered to celebrate, as an organization and as individuals, the people who carry out the work of Jobs for America's Graduates. Special Education Director Kelli Lafleur announced that tonight we wish to recognize the District's two (2) JAG specialists.

Ms. Jaslyn Griffith is a 1st year JAG Specialist implementing the Accelerated Interventions for the Middle School JAG AIM High Model Program at Bayou Chicot Elementary School. This Bayou Chicot Elementary School program had thirty (30) participants with 69% identified as one or more grades behind their peers. Some participants had IEP's and some had behavioral issues. Ms. Griffith has

exceeded our State Metrics Performance Outcome with an extraordinary promotion rate of 50% promoted to the 9th grade and 50% behavioral issues reduced.

Ms. Dianna Johnson is a veteran to the JAG Program and implemented the JAG-LA Multi-Year School Model Program for the first time at Ville Platte High School. Ms. Johnson achieved the “5 of 5” Performance Award for multi-year school. This program is currently serving 45 – 50 participants with 40% identified as one or more grades behind their peers and is providing follow-up services for an additional 20 participants. This program has achieved an extraordinary 95.8% graduation rate, exceeding National Performance Metrics as well as the State Affiliates of 90% graduation rate; 65% employment rate; 50% full-time engagement rate and enrollment in higher education.

Special Education Director Kelli Lafleur congratulated Ms. Jasalyn Griffith and Ms. Dianna Johnson for a job well done.

Item # 3 – Board President Wayne Dardeau reminded board members the Financial Disclosure Statement for 2019-2020 must be submitted to Ethics no later than thirty (30) days after the start of school for the 2019-2020 school year. A copy of the Financial Disclosure Statement was provided in each board member’s packet. **(08012019RM Attachment #01)**

There was no question or comment from board members or audience in attendance.

Item # 4 – Evangeline Parish’s quarterly Educational Excellence Fund Investment Report was presented for review. The report shows a June 30, 2019 fund balance of \$1,406,768.51. **(08072019RM Attachment #02)**

There was no question or comment from board members or audience in attendance.

Item # 5 – Technology Coordinator John Deranger gave an update to internet security issues. Mr. Deranger informed board members that for the past week and a half, all school boards throughout the state have been under a “ransom ware attack”. This is an attack where software is implemented in your software that attaches to your data and it locks up the data. Then a ransom is asked for in return for unlocking your data. If the ransom is not paid, your data becomes unreadable, you cannot access it and it cannot be utilized. It has been reported that four (4) districts across the state have been “hit”. One district was “hit” so significantly that all of their data was “wiped out”, including their back-up.

The state became proactive along with cyber terrorism experts from the national guard and implemented six (6) phases of steps to be taken to protect our data. The first step was to shut down the internet to all EPSB sites. This was done at the end of last week. The second step was to bring the internet up to selected services that were needed such as JPAMS, Munis, telephone system, email, state and federal government sites and child nutrition services. The third step was to implement all of our necessary servers and programs were being backed up properly and being protected. The rest of the steps were completed with the exception of being the internet back up at the schools. The Central Office and Media Center have been brought back up completely. Mr. Deranger stated he is working with the state to determine a feasible time to bring the schools back up with internet. All network traffic will continue to be monitored to ensure there are no compromises. If any compromise is detected we will go back into “protective mode” to protect all of our data, data of our students, and our financial data. All supervisors and principals have been alerted to the steps we have taken to this point and what will happen from this point going forward.

Item # 6 – An addendum to the Athletic Handbook was submitted for approval. **(08072019RM Attachment #03)** The addendum includes:

- The Evangeline Parish School Board will be assessed an annual fee of \$500.00 and each school will be assessed an annual fee of \$50.00, to help defray costs of the Parish Track Meet. Fee is to be paid to the host school of the Parish Meet.
- Parish Varsity Meet will be held the 1st Friday of April unless it falls during the Easter Holidays. If it falls within the Easter Holidays, it will then be moved to the following

Friday.

- Parish Elementary Meet will be held on the Tuesday before the Varsity Meet.
- No parish school shall schedule or participate in any other tournament while any Evangeline Parish athletic tournament is being hosted
- Background checks must be performed on any new EPSB employee, volunteer, CECP coach, etc.

It was moved by Mr. Arthur Savoy, seconded by Mrs. Peggy Forman, and recommended by Superintendent Darwan Lazard to approve Addendum to the Athletic Handbook, as presented.

Item #14 – Supervisor Grace Sibley informed board members that for the 6th or 7th straight year Evangeline Parish School District has had either a regional or state finalist in the Teacher of the Year or Principal of the Year and for the third time in the last six years the Evangeline Parish School District has had someone who has made it to the state finalist. Years ago, Mrs. Susan Kay Fontenot was named “Louisiana State Elementary Teacher of the Year”, the first for Evangeline Parish. More recently, Mrs. Cherie Fontenot became our first Louisiana State Elementary Principal of the Year winner; Ms. Elizabeth Chatelain became Louisiana State High School Principal of the Year finalist, and now Ms. Lisa Jack has been named 2020 Louisiana State Middle School Teacher of the Year. A standing ovation was given to Ms. Lisa Jack for being named 2020 Louisiana State Middle School Teacher of the Year.

Ms. Sibley stated that three teachers were chosen to represent Evangeline Parish in the “2020 Louisiana Teachers of the Year” Program. The state was very impressed with all three of our candidates. This is an example of the good things happening in the Evangeline Parish School District.

Item #12 – Superintendent’s Comments (Superintendent’s Comments were handled by Assistant Superintendent Michael Lombas):

- Assistant Superintendent Michael Lombas introduced the new 3rd grade French Immersion Teachers
 - Ms. Alice Renard will be teaching 3rd grade French Immersion at Mamou Elementary School. Ms. Renard is from Paris, France
 - Mr. Ali Sarr will be teaching 3rd grade French Immersion at Ville Platte Elementary School. Mr. Sarr is a native of Senegal, but has been a citizen of Ottawa, Canada for the last twelve (12) years
- Assistant Superintendent Michael Lombas thanked the Evangeline Parish community, Evangeline Parish administrators and staff, Evangeline Parish Rotary, and KVPI for the overwhelming generosity and support of the French Immersion Program and the French Immersion teachers. Through collected donations, furniture has been provided to both Ms. Renard and Ms. Sarr to completely furnish their apartments and each was given \$500 to help “set up” their apartments and help with moving expenses in coming to our country. The French Immersion teachers come to us through CODOFIL with a two year contract with an option of a third year. All of the French Immersion teachers, presently

employed, have asked to come back for a third year.

- Assistant Superintendent Michael Lombas read an email from CODOFIL Communications Officer Matt Mick. In the email, Mr. Mick states he has been contacted by Mr. Richard Fausset, a journalist with the New York Times' southern office, based in Atlanta, regarding the possibility of writing about "a newly-arrived French Immersion teacher in a school outside of the usual destinations (i.e. New Orleans, Baton Rouge, Lafayette)." Mr. Mick stated he met with Alice Renard at the CODOFIL new teacher orientation in Baton Rouge and suggested her as a potential person for Mr. Fausset. Mr. Mick felt Ms. Renard was a good fit for the story idea. Mr Fausset is requesting to be allowed to follow Ms. Renard during the upcoming first days of the school year. Assistant Superintendent Michael Lombas stated he has spoken with Ms. Renard and she has agreed to allow Mr. Fausset to "shadow" her for the first couple of school days. Assistant Superintendent Michael Lombas stated we look forward to the publicity of our French Immersion Programs in the New York Times.
- Ms. Renard and Mr. Sarr will be interviewed on KVPI radio broadcast on Friday morning, August 9, 2019.
- The first day of student instruction is set for Tuesday, August 13, 2019
- The "LAUNCH" Ceremony for the 2019-2020 school year will be held Friday, August 9, 2019 at Ville Platte High School in the gymnasium beginning at 9:30 AM
- Assistant Superintendent Michael Lombas informed board members that the Women of the United Committee of the St. Landry-Evangeline United Way honored Superintendent Lazard with the "Man With Heart" award. This award was presented to Superintendent Lazard on Saturday, July 27, 2019, at the Opelousas Civic Center.
