**Action 1: Continue working with our local cooperative specialists and district facilitators who will model lessons, visit classrooms, aid teachers, analyze writing samples, and analyze interim data.**

**Person Responsible:** Kathy Sadler and Karen Robinson for Literacy, Lori Coleman for Science, Jenny Chambliss for Math, Cindy Luper, Mary Hobbs, and Latanza Atkins

**Timeline:** Each content teacher will have a once a month observation and/or meeting with their content area specialists.

**Evaluation:** Interim data scores

**Action 2: Implement new science curriculum that is all encompassing of grades 5th through 8th.**

**Person Responsible:** Jessica Forrest, Aaron Goad, Leigh Anne Wilmoth

**Timeline:** On going year round

**Evaluation:** Post-tests, formative assessments, Interim data scores

**Action 3: Align classroom observations with professional development.**

**Person Responsible:** Principal, Assistant Principal, Math Facilitator, Literacy Facilitator

**Timeline:** Monthly informal observations for all teachers

**Evaluation:** Classroom observations and peer observations that indicate improvement in instruction and implementation of professional development strategies.

**Action 1: Use appropriate technological tools and programs to enhance student learning. Each teacher will implement Odysseyware to enrich and enhance students' content knowledge and 5<sup>th</sup> and 6<sup>th</sup> grade teachers will be trained in the new RISE initiative.**

**Person Responsible:** Literacy Facilitators and Math Facilitators

**Timeline:** Odysseyware will be used once a week continuing throughout the school year.

**Evaluation:** The successful completion of content area units while working towards the completion of grade level courses.

**Action 2: Teachers will mix traditional classroom instruction with online delivery of instruction and content, granting the student a degree of control over time, pace, and/or path.**

**Person Responsible:** Patti Smith

**Timeline:** A mixture of instructional techniques will be used daily.

**Evaluation:** This will be shown through the increase in student knowledge and retainment of information.

**Action 3: Assess student learning frequently by using a variety of evaluation methods while maintaining a record of the results. Each teacher will then use this data in a timely manner to guide their instruction for lessons to come.**

**Person Responsible:** Math and Literacy Facilitators, Lori Coleman, and Patti Smith

**Timeline:** Assessment of student learning will be daily through formative and/or summative assessments.
