

Minutes of the Perryville School District Board Meeting

A special meeting of the Perryville School District was held on Tuesday, May 3, 2022. Board members present were Cory Cox, Stephanie Emery, John Roland, and Bobby Scott

The special school board meeting was called to order at 6:00 p.m. by Mr. Cory Cox, President.

- ***Classified PPC Salary Schedule***

Dr. Davis read a statement from Melissa Dillinger, CPPC Chair, which stated; I (Melissa Dillinger) give permission to Dr. Davis to serve as designee for the CPPC to present the addition to the classified salary schedule to the school board to include a salary schedule for transportation supervisor with two or more relevant certifications/licenses. Dr. Davis told the board the addition amount would be \$43,860.00. Dr. Davis made recommendation to adopt the salary schedule of transportation supervisor with two or more relevant certifications/licenses for the amount of \$43,860.00 to the classified salary schedule. Dr. Davis made recommendation to hire Billy Prince as transportation supervisor with two or more relevant certifications/licenses for the amount of \$43,860.00 for the 2022-2023 school year and hire as split driver for the special education bus route for the 2022-2023 school year. Bobby Scott made motion to accept Dr. Davis' recommendation, Stephanie Emery seconded the motion. The vote was 3-0 with all being in favor. Cory Cox did not vote. Motion carried.

Dr. Davis made recommendation to hire Jamie Campbell as maintenance for both campuses for the 2022-2023 school year. Bobby Scott made motion to accept Dr. Davis' recommendation, Stephanie Emery seconded the motion. The vote was 3-0 with all being in favor. Cory Cox did not vote. Motion carried.

Dr. Davis made recommendation to replace the contract for Allan Fairbanks from beginning date May 2, 2022 and end date of June 17, 2022 to beginning date May 11, 2022 and end date June 17, 2022. John Roland made motion to accept Dr. Davis' recommendation, Bobby Scott seconded the motion. The vote was 3-0 with all being in favor. Cory Cox did not vote. Motion carried.
