The **Parent Survey for Special Education** is for parents and caregivers of children from 3 years old and above who are currently (or recently) on an Individualized Education Program (IEP).

The new Parent Survey has 13 questions and should take 8 minutes or less to complete.

The Parent Survey is produced through a partnership between the Oklahoma State Department of Education - Special Education Services (OSDE-SES) and the Oklahoma Parents Center (OPC).
