The Allen Parish School Board met in regular session at the Allen Parish School Board Office in Oberlin, Louisiana, on Monday, July 9, 2018, at 5:00 p.m. with the following members present:

Steven Sumbler, President; Cathy Farris, Vice-President; Gregory Monceaux; Susie Reeves; and Jason Turner

The meeting began with the invocation given by Jason Turner.

Motion by Gregory Monceaux, seconded by Jason Turner, unanimously carried to approve the minutes of the June 11, 2018, regular meeting.

Motion by Gregory Monceaux, seconded by Jason Turner, unanimously carried to approve the payment of bills authorized by the Finance Committee.

Motion by Susie Reeves, seconded by Gregory Monceaux, unanimously carried to renew the 2018-2019 insurance policies for property, boiler and machinery, and worker's compensation.

Motion by Jason Turner, seconded by Gregory Monceaux, unanimously carried to accept the 2018-2019 official journal bid of \$5 per column inch from the Oakdale Journal.

Motion by Cathy Farris, seconded by Gregory Monceaux, unanimously carried to approve the following retirement/resignations:

Motion by Gregory Monceaux, seconded by Jason Turner, unanimously carried to authorize the president to sign the Board Certification Form for the Unified Application for Federal Funds for fiscal year 2018-2019.

2. Summer remediation is complete and test results should be available tomorrow, July 10, 2018.

Students Report – August 10, 2018
4. The Oakdale Elementary Rebuild Project has had some setbacks due to rainy weather and roof problems.
5. Beginning with the 2018-2019 school year, any student seeking to transfer to a public school in grades 5 and 9 from any in-state nonpublic school, approved home study program or out-of-state school, shall be required to pass the English language arts and mathematics portions of the state placement test.
6. The Board was reminded to complete the Board of Ethics Disclosure Statement that is due by August 31, 2108.
