A hospitality room will be available for coaches and judges. A concession stand will be available all day for contestants. Meal tickets may be purchased for students in advance at \$6/student. Meal will include Chick Filet sandwich or 4-slices of pizza, snack, and drink. Awards: Medals will be given for 1 st – 3 rd and ribbons for 4 th – 6 th places in each event. No team awards will be given in any event. Fees: \$20 per student with unlimited events for that student except CX and LD Debate. Debate fees: \$35 per LD entry and CX team. Judges for debate: the schools must bring judges with them or the student(s) will not be allowed to enter the competition. LIMITED # of LD and CX Debaters!!!! If you need for us to hire a judge for your school, you must give advance notice to Ms. Wilcox. Maximum cost for fees per school \$450 (excluding meal tickets & judges fees). We do NOT charge for last minute drops. If your students want to enter conflicting events , please let us know in advance, prior to the date of the event. We should not have any problem making the accommodations! Written contest: Any written contest may be completed prior to the Saturday meet.
