Should any final action, final decision, or final vote be required in the opinion of the School Board with regard to any matter considered in such closed meeting then the final action, final decision, or final vote shall be either: in the open meeting covered by the Notice upon the reconvening of the public meeting; or at a subsequent public meeting of the School Board upon notice thereof; as the School Board shall determine.

## **Comments from Visitors**

A maximum of (30) minutes will be allotted for this section, with each person being allowed no more than (5) minutes. Any person/group wishing to address the Board must sign in on the Open forum list no later than 5:30PM. Groups of five or more shall select a representative to speak for the group; the representative will have five minutes. The Board may not act on any matter not on the agenda. Per Board Policy GF (local) members of the public having complaints or concerns may present their complaints or concerns to the Board only after following the procedure defined in that policy. The Board intends that, whenever feasible, complaints shall be resolved at the lowest possible Administrative level. If a complaint comes before the Board that involves concerns or charges regarding an employee or student, it shall be heard by the Board in closed session unless the employee or student to whom the complaint pertains requests that it be heard in open session.
