

DISTRICT ONE: Single-Member District One shall consist of all that territory described as follows:

BEGINNING at a point in the City of Laredo where the centerline of Ejido Avenue intersects with the centerline of Lomas Del Sur Boulevard (formerly Southgate Blvd), also being the United I.S.D. boundary, for the northeast corner and POINT-OF BEGINNING of this District;

THENCE, in a southerly direction along the centerline of Ejido Avenue to the intersection with the centerline of La Pita Mangana Road;

THENCE, in a westerly direction along the centerline of La Pita Mangana Road to the intersection with the centerline of U.S. Highway 83 (Zapata Highway);

THENCE, in a southerly direction along the centerline of U.S. Highway 83 to the intersection with the centerline of a private unnamed road, approximately 0.75 mile south of Cielito Lindo Boulevard;

THENCE, in an easterly direction along the centerline of the private unnamed road to the intersection with the corporate limits of the City of Laredo;

THENCE, in an easterly direction along the corporate limits of the City of Laredo to the intersection with the centerline of San Idelfonso Creek;

THENCE, in a southwesterly direction along the centerline of San Idelfonso Creek to the intersection with the corporate limits of the City of Laredo;

THENCE, in an easterly, southerly, easterly, and southerly direction, respectively, along the corporate limits of the City of Laredo to the intersection with the centerline of Mangana-Hein Road;

THENCE, in an easterly and southeasterly direction, respectively, along the centerline of Mangana-Hein Road to the United I.S.D. boundary;

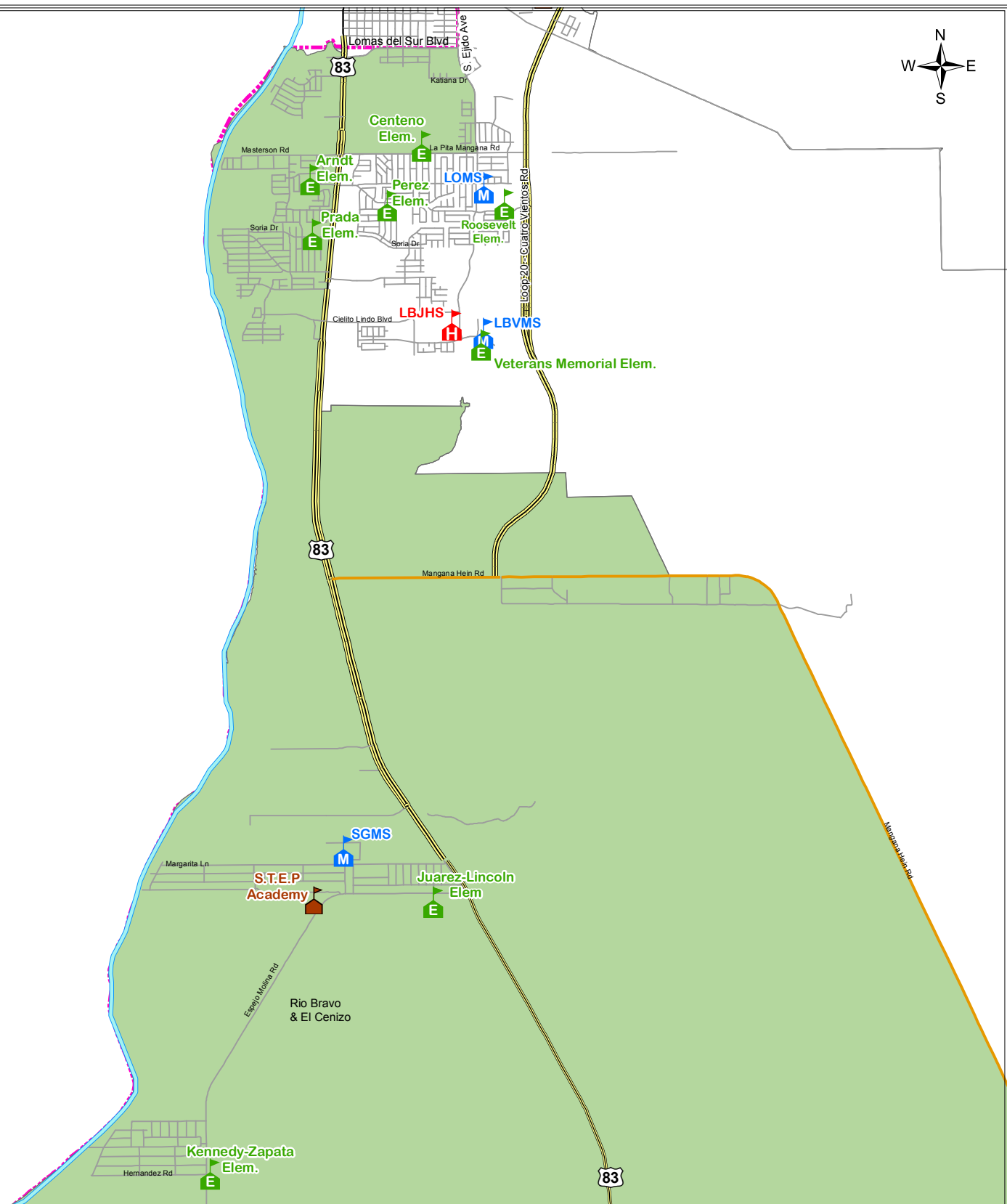
THENCE, in a southern, northwestern, and southwesterly direction, respectively, along the United I.S.D. boundary, also being the common boundary between Webb County and Zapata County, to the intersection with the International Border at the Rio Grande River;

THENCE, in a northerly direction along international Border at the Rio Grande, and its meanders, to the intersection with the centerline of an unnamed creek, west of Lomas Del Sur Boulevard (formerly Southgate Boulevard) for the northwest corner of this District;

THENCE, in an easterly direction along the centerline of the unnamed creek, and its meanders, west of Lomas Del Sur Boulevard, to the intersection with the centerline of U.S. Highway 83;

THENCE, in a southerly direction along the centerline of U.S. Highway 83 to the intersection with the centerline of Lomas Del Sur Boulevard (formerly Southgate Boulevard);

THENCE, in an easterly direction along the centerline of Lomas Del Sur Boulevard (formerly Southgate Boulevard) to the intersection with the centerline of Ejido Avenue, for the POINT-OF-BEGINNING of this District.
