- 2. Pursuant to Section 551.074 of the Texas Government Code, deliberation concerning possible resignation and release agreements with an Elementary teacher and a Spanish teacher who have been proposed for non-renewal based upon a RIF.
- 3. Pursuant to Section 551.074 of the Texas Government Code, deliberation concerning possible recissions of proposed non-renewals of an Elementary teacher and a Spanish teacher and acceptance of the resignation of the teachers.
- 4. Pursuant to Section 551.071 of the Texas Government Code, consultation with the attorney for the Board concerning legal and procedural issues involving employee non-renewal hearings based on a RIF.
- 5. Pursuant to Section 551.074 of the Texas Government Code and Section 21.207 of the Texas Education Code, conduct a hearing on and deliberate concerning the proposed non-renewals of an Elementary teacher and a Spanish teacher based on a RIF.
