<u>Fast Bridge Data – Fall Assessments</u>

Superintendent Smith reported that the Leadership for Tomorrow group met on Friday, September 10, 2021 and were very impressed with what the school district is doing with our redesign.

He also reported that the State KASB Convention will be in Overland Park, Kansas on November 6 & 7, 2021. Board President Miranda Dinkel and Merlyn Ramsey expressed interest in attending the convention.

Transportation for Welding

Board member Tasha Willett requested that the administration find a way to transport students taking welding classes at Chanute through Neosho Community College. After discussion, Superintendent Smith said that he would arrange transportation for those students who wanted it.

Merlyn Ramsey stated that he had not been able to attend the September 8, 2021 meeting.

Dr. Jennifer McKenney

Board President Miranda Dinkel asked that Dr. McKenney present the science behind wearing the masks in schools and studies showing what is helping to prevent the spread of the COVID virus.

After discussion, Dr. Jennifer McKenney made a motion to mandate masks for a period of eight weeks to prevent the spread of the COVID variant and to re-evaluate the need for masks at the end of the eight-week period. Motion seconded by Board President Miranda Dinkel. Motion failed. 2-4

Feyn Baker requested his vote be recorded in the minutes as No.

Board members expressed concern that too much time was being dedicated to COVID and not enough time to teaching and learning.

After further discussion, Tasha Willett made a motion to maintain the gating criteria but to make mask wearing completely optional to the student, parent and/or employee. Motion seconded by Feyn Baker. Motion failed. 2- yes; 2-no; 2-abstained.

KDHE/ELC Grant

Superintendent Smith presented to the board USD 484 received the "Test to Stay & Learn" grant from KDHE for \$1.2 million dollars. Daily rapid testing will be conducted each morning for students and staff that are in quarantine. The participants will be allowed to return to school and school activities for a period of 24 hours with a negative test result. Everyone in the program must wear a mask those that fail to wear their mask appropriately will be required to stay home.

Merlyn Ramsey made a motion to accept the KDHE testing grant with parental consent given once per year and to administer daily rapid testing for our students/staff in quarantine. Motion seconded by Vice President Adam Kiblinger. Motion carried. 6-0
