Fredonia Recreation Board Update

He reported that Governor Laura Kelly announced Wednesday, July 15, that her intent is to sign an executive order that would delay school re-opening until September 9, 2020 due to COVID-19 concerns on Monday.

Superintendent Smith informed the Board these documents were prepared over the past few weeks with members of his district and administrative leadership teams. He was grateful for all of their hard work. Board President Miranda Dinkel also shared her appreciation for a well-prepared plan. Superintendent Smith reminded everyone this was a draft document and our final plan will be presented in August.
