Return to School Plan

Quick Look

- USD 484 will implement Executive Order 20-59 in our reopening plans while it is in place.

Definitions:

- On-site Learning Environment: Students and teachers will be in school with or without social distancing practices put into place.
- Hybrid Learning Environment: Students will be spending part of their time in the classroom and part of their time learning virtually from home.
- Modified Quarantine Learning Environment: Students and teachers at Lincoln and the Early Learning Center will be on a modified schedule where they will receive all services in the classroom, when possible.
- Remote Learning Environment: Students will be doing all of their learning from home and not entering the school building at all.
