Call to Order

Board President, Mrs. Susannah Osley called the meeting to order at 1:00 p.m.

Opening Business

Public Comment for Items on the Agenda

There was no public comment.

Approval of Agenda

Mrs. Jessica Smith made the motion to approve the Agenda. Mrs. Jacqueline Duran seconded. Motion carried 5-0, members: Crail, Duran, Osley, Smith, and van Duinwyk.

Strategic Initiative #4. Safe, Efficient Facilities (Improve the safety, efficiency, accessibility, and utility of our physical structures and grounds to support student learning. Ensure all structures are properly maintained. Develop and implement a vision for our adjacent property in keeping with our Strategic Plan.)

Award Contract For MUSD Library/Media Center HVAC

Mr. Anthony Ranii explained that the HVAC system in the Library Media Center, Technology Offices, and the Innovation Lab has been in disrepair and is in need of replacement. He reported that six contractors attended the job walk and four contractors submitted bids for the project:

Quincon \$399,809 EJS Inc. \$467,000 SBS Corporation \$471,838 Los Angeles Air Conditioning, Inc. \$682,800

Mr. Anthony Ranii explained that Project Manager, Leo Perez vetted all companies and he was recommending the contract to Quincon, following the public regulations of awarding the contract to the lowest responsible bidder. Ms. Virginia Alvarez spoke to the budget planned to use ESSER III monies towards the cost of the project, however with the bids being higher than anticipated the ESSER III funds will not cover this expense and the General Fund monies will be used.

Ms. Kim Crail made the motion to approve Quincon Construction for the MUSD Library/Media Center HVAC Project. Mr. Peter van Duinwyk seconded. Motion carried 5-0, members: Crail, Duran, Osley, Smith, and van Duinwyk.

Building D- Windows and Doors, Phase II Update

Mr. Anthony Ranii explained that the Building D Window Replacement Project had been split into two phases as the windows and doors needed to be replaced in Building D and that was included in the larger part of the renovation planed for Building D. He reported that six contractors attended the job walk and four contractors submitted bids:

Tomar Construction \$376,800 EJS Inc. \$386,700 SBS Corporation \$581,482 Quincon \$797,588

He explained that Project Manager, Leo Perez vetted all companies and during this process it was noted that Tomar Construction did not provide the names of the subcontractors that they would be using on the project, more specifically the subcontractor for the mitigation of hazardous waste. Mr. Anthony Ranii explained that he reviewed the process with the attorney for MUS and it was recommended to allow Tomar Construction to submit the required information on March 1st. Tomar Construction claimed that there was no disclosure of hazardous waste, however the documentation was given to all bidders. The attorney made the recommendation to send a notice of intent to award the contract to EJS Inc. if Tomar Construction does not submit the required subcontractor information. Mr. Anthony Ranii explained that there is no recommendation being made and that this item will come back for board approval at the March 15th board meeting.

Mr. Peter van Duinwk inquired as to the specifications of awarding contracts to local businesses. Ms. Virginia Alvarez explained that the request for bids is posted to a local company Tri Co Blue which targets all contractors, including local contractors.
