Regular Board Meeting  
August 10, 2020

A regular meeting of the Iredell I.S.D. Board of Trustees was called to order at 7:35p.m. by President Patrick Proffitt. Board members present were Robbie Gephart, Zeke Wilson, Wayne Johnson, Nathan Potter and David Fowler. Also present were Ben Eubanks, Debra Burn and Bradley Fletcher. Absent was Brad Wilkerson.

Mr. Eubanks went over the budget for the 2020-2021 school year.

A motion was made by Robbie Gephart to approve the previous minutes. David Fowler seconded. Motion carried unanimously.

There was no public forum.

After reviewing the bills, a motion was made by Robbie Gephart to approve payment. Wayne Johnson seconded. Motion carried unanimously.

A motion was made by David Fowler to approve the Board Policy Update 115 effecting local policies. Zeke Wilson seconded. Motion carried unanimously.

A motion was made by Patrick Proffitt to approve a Resolution of the board regarding exclusion from extracurricular activities. Wayne Johnson seconded. Motion carried unanimously.

A motion was made by Robbie Gephart to approve Chelsea Dorward and Christopher Coon as Adjunct Faculty members of Iredell ISD. Nathan Potter seconded. Motion carried unanimously.

A motion was made by Nathan Potter to approve the agreement with Bosque County Education Coop. Zeke Wilson seconded. Motion carried unanimously.

After discussion on the price changes for the school breakfast and lunch, motion was made by Patrick Proffitt to raise them. David Fowler seconded. Breakfast for paying students will be \$ 1.50. For adults and visitors, the price will be \$2.50. Lunch for paying students will be \$ 3.25. For adults and visitors, the price will be \$ 4.25. Motion carried unanimously.

After reviewing the 2020-2021 Student Code of Conduct, a motion was made by Nathan Potter to approve. Wayne Johnson seconded. Motion carried unanimously.

Superintendent Eubanks and the board discussed the 2020-2021 Student Handbook.

Superintendent Eubanks and the board discussed the value lag in district funding.

After a discussion of the proposed M & O tax rate for the 2020 tax year of .88400, a motion was made by Patrick Proffitt to approve. David Fowler seconded. Motion carried unanimously.

After a discussion of the proposed I & S tax rate for the 2020 tax year of .19680, a motion was made by David Fowler to approve. Robbie Gephart seconded. Motion carried unanimously.

Superintendent Eubanks updated the board on UIL Guidelines for football games, new staff and upcoming events. Due to Covid-19, the attendance to games will be at half capacity with spacing between family groups. The concession stand items will be limited to drinks, candy, and prepackaged items. New staff members and their duties were updated. The school will be getting bottle filling stations in each building and turning the water fountains off. Meet the teacher for elementary students, junior high and high school schedule and chrome book pick ups will be next week at designated times.

A motion was made by Patrick Proffitt to adjourn at 8:20 p.m. David Fowler seconded. Motion carried unanimously.
