Dear Sinton ISD Students, Parents, Families and Staff:

I am thankful for your support as we have successfully implemented safety protocols throughout the school year. As you know, the governor's order to open business capacity to 100% and remove the mask mandate went into effect on Wednesday, March 10th while we were on spring break.

The Texas Education Agency has published updated public health guidance for public schools. A key phrase in the guidance is "Every student, teacher, or staff member shall wear a mask over the nose and mouth when inside a school building, school facility, facility used for school activities, or when in an outdoor space on school property or used for school activities, wherever it is not feasible to maintain six feet of social distancing from another person not in the same household....." While there are a few exceptions, the general rule remains that masks should be worn.

What is new is that there is a mechanism where the school board can take action to modify or eliminate this mandate. At this time, I am <u>NOT</u> recommending that the board make any changes to the mask mandate. Here are my reasons why:

- What we have been doing is working. Throughout this school year, we have not had any confirmed cases of person to person spread on a campus, but we have seen a lot of person to person spread within families, following breaks, following events (such as parties, weddings, sleepovers, etc.). I see no reason to jeopardize an outbreak or mass quarantine when we only have a few weeks left in this school year.
- The close contact rules have not changed. If we were to stop wearing masks, then our numbers having to go home due to close contact would likely increase tremendously. I want us to finish strong and have all of our students and staff here on campus each day. Plus, we have many extracurricular activities going on during the spring and I want those to be able to continue. Remember, last year, our baseball, softball, track, tennis, golf, UIL academic, and one act play teams didn't get to even start district competition due to COVID. They deserve to get to complete a full season this year and an outbreak or a mass quarantine would hinder those student's opportunities to compete.
