Hello Parents,

We have been working on a method to continue providing nutritious meals for the children of Thorndale while at the same time, minimizing contact with each other to protect the staff that is working to prepare and distribute those meals. We are taking every precaution possible to prevent the spread of COVID 19 but we feel that we must take an additional step out of an abundance of caution. **STARTING TUESDAY, APRIL 7TH, THORNDALE ISD WILL HAVE ONE DAY A WEEK MEAL PICK UP. WHEN YOU PICK UP YOUR MEALS IT WILL BE 5 DAYS OF BREAKFAST AND 5 DAYS OF LUNCH.** Some of these meals will need to be heated up before eaten. Instructions will be attached.

We will be giving out meals daily through Friday, April 3rd. On Friday, we will give both meals for Monday and breakfast for Tuesday morning.

Instructions for picking up meals without children present

Effective April 3, 2020, parents may pick up meals without their children present at our Thorndale ISD feeding site. Parents must provide one of the following types of documentation when picking up a meal without the child present:

- Child's birth certificate (born 2001-present)
- Student report card (does not have to be TISD)
- Student ID card from any district(TISD does not have a student id card and it does not have to be TISD)

Curbside meals are intended to be picked up for your own family, not for others. The documentation can be held up to the window for staff to inspect. We will not ask to touch the document or get a copy. There must be one piece of documentation for each child not present to receive a meal. **Documentation is not required when a child is brought to the meal site.**

Any child under the age of 18 years old, can receive free meals here at our location. They do not have to be a Thorndale ISD student to receive meals.
