Meal Charge Policy

Students are allowed to charge up to 3 lunches and 2 breakfast on our charge policy. This amount varies depending upon the student's rate for meals.

- Reduced Meal Students can charge \$1.80.
- K-5 Paid Meal Students can charge \$9.75
- 6-12 Paid Meal Students can charge \$10.50

Please note: No A La Carte items (extras like ice cream or chips) are allowed to be charged at any time.

Alternate Meals

Once a student has reached their charge limit, an alternate meal will be served free of charge. This alternate meal will consist of a cheese sandwich, fruit, and milk.

Grace Periods

Grace periods for last year's applications ends on 10/4/2019. By law a new application **must** be completed each year to determine eligibility. If you have not turned in an application yet, please do so. You may pick up an application at any of the campus offices.

Applications

Applications must be completed entirely to be processed. Before turning them in check that:

1. the last 4 digits of your Social Security Number is filled in.
2. all members of the household are listed even if they are not enrolled in school or receiving income.
3. income is listed legibly with frequency clearly circled.
4. the application is signed.

EDG Numbers

Please note: Applications cannot be processed with Medicaid numbers or Case numbers. The EDG (Eligibility Determination Group) number provided by the State must be listed on the application or the income portion must be filled out instead.

Lunch Money Now

Lunch Money Now is a great tool to access your student's lunch account. You may deposit money into their account, see what they are eating every day, an set up to receive notifications by text or email when their account balance is low. To set up your child's account, you will need their birth date and their student ID/Lunch number.

Negative Balances

Please note: Parents are responsible for any charges accrued prior to their child's application being completed and finalized
