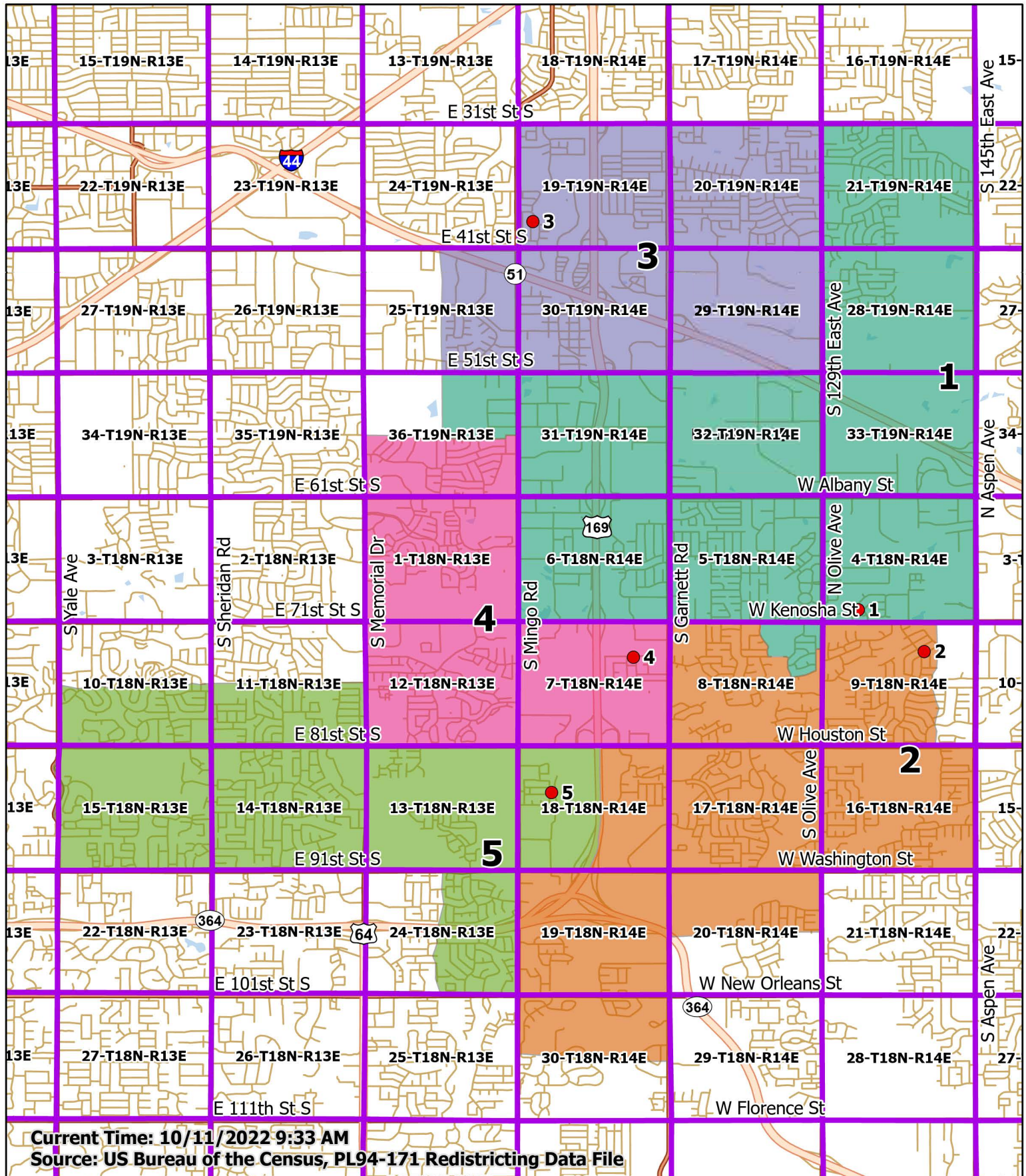
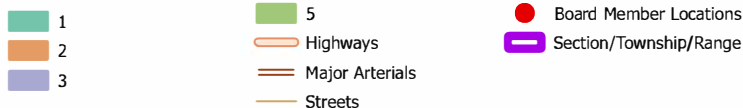


Union Public Schools Board Member Districts

Union Public Schools Board Member District

Boundary Descriptions

Ward 1:

ALL OF that part of the territory included within the Union Public School District in Sections 21, 28, 31, 32 and 33 Township 19 North Range 14 East and Sections 4, 5 and 6 Township 18 North Range 14 East

AND ALSO all that part of the territory included within the Union Public School District in Section 36 Township 19 North Range 13 East lying north of the following defined boundary; beginning at the intersection of the centerlines of East 56th Street South and South Mingo Road; thence west along the centerline of East 56th Street South to the centerline of South 95th East Avenue; thence south along the centerline of South 95th East Avenue to the centerline of East 56th Street South; thence west along the centerline of East 56th Street South to the school district boundary

AND ALSO all that part of the territory included within the Union Public School District in Section 8 Township 18 North Range 14 East lying north and east of the following defined boundary; beginning at the intersection of the centerlines of West Kenosha/East 71st Street South and North Willow Avenue; thence southerly along the centerline of North Willow Avenue to the centerline of West Freeport Street and the south line of Census Block 401430074121001; thence east along the centerline of West Freeport Street and said block boundary line to the centerline of North Sweet Gum Avenue; thence southerly along the centerline of North Sweet Gum Avenue to the centerline of West Detroit Street; thence easterly along the centerline of West Detroit Street to the centerline of North Palm Avenue; thence north along the centerline of North Palm Avenue to the centerline of West Greeley Street; thence east along the centerline of West Greeley Street to the centerline of North Olive Avenue/South 129th East Avenue, which is the east line of said section.

Ward 2:

ALL OF that part of the territory included within the Union Public School District in Sections 9, 16, 17, 19, 20 and 30 Township 18 North Range 14 East

AND ALSO all that part of the territory included within the Union Public School District in Section 8 Township 18 North Range 14 East lying south and west of the following defined boundary; beginning at the intersection of the centerlines of West Kenosha/East 71st Street South and North Willow Avenue; thence southerly along the centerline of North Willow Avenue to the centerline of West Freeport Street and the south line of Census Block 401430074121001; thence east along the centerline of West Freeport Street and said block boundary line to the centerline of North Sweet Gum Avenue; thence southerly along the centerline of North Sweet Gum Avenue to the centerline of West Detroit Street; thence easterly along the centerline of West Detroit Street to the centerline of North Palm Avenue; thence north along the centerline of North Palm Avenue to the centerline of West Greeley Street; thence east along the centerline of West Greeley Street to the centerline of North Olive Avenue/South 129th East Avenue, which is the east line of said section.

AND ALSO all that part of the territory included within the Union Public School District in Section 18 Township 18 North Range 14 East lying east of the north bound lanes of US Highway 169/US Highway 64/South Pearl Harbor Expressway/South Mingo Valley Expressway

Ward 3:

ALL OF that part of the territory included within the Union Public School District in Section 25 Township 19 North Range 13 East and Sections 19, 20, 29 and 30 Township 19 North Range 14 East

Ward 4:

ALL OF that part of the territory included within the Union Public School District in Sections 1 and 12 Township 18 North Range 13 East and Section 7 Township 18 North Range 14 East

AND ALSO all that part of the territory included within the Union Public School District in Section 36 Township 19 North Range 13 East lying south of the following defined boundary; beginning at the intersection of the centerlines of East 56th Street South and South Mingo Road; thence west along the centerline of East 56th Street South to the centerline of South 95th East Avenue; thence south along the centerline of South 95th East Avenue to the centerline of East 56th Street South; thence west along the centerline of East 56th Street South to the centerline of South Memorial Drive and the school district boundary

Ward 5:

ALL OF that part of the territory included within the Union Public School District in Sections 10, 11, 13, 14, 15 and 24 Township 18 North Range 13 East

AND ALSO all that part of the territory included within the Union Public School District in Section 18 Township 18 North Range 14 East lying west of the north bound lanes of US Highway 169/US Highway 64/South Pearl Harbor Expressway/South Mingo Valley Expressway
