## 2018-2019 Queen City ISD District Parent and Family Engagement Policy

### Part I. GENERAL EXPECTATIONS

The Queen City ISD agrees to implement the following statutory requirements:

- The school district will put into operation programs, activities, and procedures for the
  involvement of parents in all of its schools with Title I, Part A programs consistent with
  section 1118 of the Elementary and Secondary Education Act (ESSA). Those programs,

- Queen City ISD will take the following actions to engage parents in the joint development of
  its district parental engagement plan under section 1112 of the ESSA: Parents will serve on
  the district and campus site-based committees which write the district and campus
  parental involvement policies. Parent input will be solicited at Title I meetings.
- Queen City ISD will take the following actions to engage parents in the process of school review and improvement under section 1116 of these ESSA: Parent input will be solicited at Title I meetings and district site-based committee parent members will help in the school review.
- 3. The school district will, with the assistance of its schools and parents, at annual faculty meetings and district and campus site-based meetings educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools.
  - D. The school district will, to the extent feasible and appropriate, coordinate and integrate parental engagement programs and activities with our PreK3 and PreK4 preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children.

The school district will require that each principal provide to parents information related to the school and parent programs, meetings, and other activities, and that it is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand.
