The last member of the public was Mr. Rodney Davis. He and some of his students shared with the Governing Board a project the recently worked on. The students shared maps and essays they wrote.

7. SUPERINTENDENT INFORMATION/DISCUSSION

Mrs. Rico-Beaucage provided an enrollment update. She shared photos of trainings and events that have taken place on campus. They included Learning Walks that took place on December 2. The next scheduled Learning Walks will be February 8 and April 26. Mrs. Rico-Beaucage invited Board members to attend the Learning Walks. B. COVID 19 Update

Director of Student Services, Steve Lathen provided a COVID Update to the Governing Board. Mr. Lathen noted that the Covid Task Force met and discussed the increase in cases. The task force recommended making a few minor changes. Those included increasing of hand washing, increase the spraying/sanitizing of playground equipment more frequently. As well as encouraging classrooms to allow 3ft or more of space for students and to encourage mask wearing while working in small groups. The task force recommends we stay in phase III. In the Task Force meeting some concerns brought up were the quarantine time and for those students in close contact. With the Superintendents permission we are currently exercising a test to stay pilot program. In addition Mr. Lathen noted we will continue onsite learning after winter break. Upon return from break, at 7am on January 3rd the Nurse will provide onsite Covid testing for staff. Mr. Lathen also shared the Continental website and the COVID-19 information Dashboard with Covid cases for Continental School District.

A. Budget Revision #2 for FY22

Business Service Manager, Greg Schubert recommended approval of FY22 Budget Revision #2.
