#### 14. GOVERNING BOARD INFORMATION/DISCUSSION

Governing Board member Shelley Kais questioned why the decision was made to have the 5<sup>th</sup> grade class go virtual. Mrs. Cuevas explained that over the course of two school days, we had 6 students test positive. In addition we had two teachers out due to COVID. When this occurred she made the decision to have the students go virtual for the remainder of the week to assist in stopping the spread of the virus. Mrs. Kais noted she asked that question because the metric they are using nationally is 40% and we used 30% when deciding to close a classroom. She asked that we consider this when closing a class. As a Board we have a legal requirement and would like to see this be discussed at a future meeting.

Governing Board member Kelley Allen complimented Nurse Maureen for providing COVID testing daily. She noted she has seen that line of vehicles that Nurse Maureen has been testing. She really appreciates that we are providing the test to stay option.

Governing Board member Richard Ulery commented about the 5<sup>th</sup> grade class having to go to virtual learning this week. He is alarmed at the long term and permanent damage that we are doing to our kids educationally, mental health that is caused by virtual learning, isolation and quarantine guidelines, absences and yes mask requirements. Masks are not stopping the spread of COVID. It has been proven that our kids are least vulnerable to this disease, to infection or having serious health problems due to this disease. Our students need to be in class. If they are sick they need to stay home.

Governing Board member Andrew McGibbon expressed his appreciation to be allowed to serve as President of this Board.

Governing Board President Stephen Oesterle stated he is honored to take the position of President.
