## Bowie 6 School Title I Parent Engagement Plan Revised 05/19/20 Amarillo Independent School District

## PART I. General Expectations

Bowie 6 agrees to implement the following statutory requirements:

**PART II.** Description of how Bowie 6 will implement the required components of the campus Title I Parent Engagement Plan.

- 1. Bowie 6 will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:
  - Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
  - Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan. - 2. Bowie 6 will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:
  - Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
    - O Parents, staff, and community members will be invited to serve on the Bowie 6 campus committee. Meetings will be held throughout the year and parents will be invited to attend and provide input regarding the Campus Improvement Plan. Annual training will be provided to all members of the committee.
  - Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
    - O Bowie 6 staff members will review the CNA and CIP with administrators during August professional development. During this time, they will also receive training and information regarding the Title 1 program for our campus.
  - Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their

Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

- 3. Bowie 6 will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:
  - Bowie 6 will invite all parents to attend Open House on September 13, 2018, to discuss the school's participation in the Title 1 A programs and requirements.
  - The information will be delivered in English and Spanish.
- 4. Bowie 6 will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:
  - This information will be provided, in English and Spanish, at a parent information meeting during Open House
  - Report Cards/ Progress Reports
  - Access to Texas Assessment Site
- 5. Bowie 6 will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possibly. These may include, but are not limited to, the following:
  - Parents may access the school's website or Facebook page for information regarding school events.
  - The school phone number and staff emails are readily available for parents to contact school personnel with suggestions or comments.
  - Parents will also be able to voice their opinions through school surveys and the Parent Collaboration.
- 6. Bowie 6 will provide each parent Skyward Parent Access login information and instructions to retrieve an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:
  - Parent notices are sent home to inform parents about getting their login information for Skyward to access student assessment reports. In addition, call outs were made to ensure all parents were notified of the process for access student state assessment

reports through the Texas Assessment Parent Portal. Notices were made in English and Spanish.

- 7. Bowie 6 will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following:
  - Reviewing and understanding the state's academic content standards.
  - Reviewing and understanding the state's student academic achievement standards.
  - Reviewing and understanding the state and local academic assessments including alternative assessments.
  - The requirements of Title I, Part A.
  - How to monitor their child's academic progress.
  - How to work with educators.
  - Other topics that received strong parent interest as reflected by the Title I school Parent Engagement Survey.
- 8. Bowie 6 will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:
  - Warrior Night.
  - Discovery Center Science Night
  - SBDM Meetings
  - Skyward Parent Training.
  - Parent Collaborators
  - Open House (Fall & Spring)
  - Parent Conferences

NOTE: Translators will be available for all parent nights offered on campus.

- 9. Bowie 6 will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:
  - Using parent surveys and evaluations, Bowie 6 will determine what areas of parental communication need to be addressed and will provide professional development or training on effective communication strategies that include the parent as a partner in education.

- 10. Bowie 6 will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:
  - All school information will be shared with parents in English and Spanish through
    notices sent home, calls outs, school website, and social media sites. Translators are
    also available on campus for conferences.

## PART III. Discretionary Components of the Bowie 6 Title I Parent Engagement Plan
