- 2) THE FIRST AMERICAN PRESIDENT EVER TO VISIT THE SOVIET UNION WAS RICHARD NIXON.
- 3) BURGLAS BROKE INTO THE WATERGATE COMPLEX INTENDING TO STEAL CAMPAIGN INFORMATION FROM THE DEMOCRATIC PARTY HEADQUARTERS.
- 4) EVIDENCE ON WATERGATE SEEMS TO SHOW THAT NIXON ORDERED THE COVER-UP.

- 6) THE PROSPERITY OF THE 1950s AND 1960s RESTED IN LARGE PART ON EASY ACCESS TO RAW MATERIALS AROUND THE WORLD AND A STRONG MANUFACTURING INDUSTRY.
- 7) BY THE 1970s, THE U.S. ECONOMY HAD BECOME HEAVILY DEPENDENT ON IMPORTED OIL.
- 8) THE ENERGY CRISIS OF THE 1970s WAS IN LARGE PART A RESULT OF OPEC PRICE INCREASE AND GOVERNMENT REGULATIONS OF THE OIL INDUSTRY.
- 9) PRESIDENT CARTER IMPOSED AN EMBARGO ON THE SALE OF GRAIN TO THE SOVIET UNION AS A RESULT OF THE SOVIET INVASION OF AFGHANISTAN.
- 10) AS PART OF HIS SOUTHERN STRATEGY, NIXON TOOK STEPS TO SLOW DESEGREGATION.
- 11) AS PART OF NIXON'S NEW FEDERALISM POLICY, CONGRESS PASSED REVENUE-SHARING BILLS.
- 12) A MAIN PURPOSE OF NIXON'S TRIP TO CHINA WAS TO ENCOURAGE THE SOVIETS TO MORE ACTIVELY PURSUE DIPLOMACY.
- 13) AS PART OF THE STRATEGIC ARMS LIMITATIONS TREATY, NIXON AND BREZHNEV AGREED TO EXCHANGE SCIENTIFIC INFORMATION.

- 14) NIXON'S "ENEMIES LIST" WAS COMPOSED OF ANYONE HE SUSPECTED OF BEING A THREAT TO HIS PRESIDENCY.
- 15) NIXON TRIED TO AVOID TURNING OVER THE WATERGATE TAPES BY CLAIMING THAT THE TAPES WOULD COMPROMISE NATIONAL SECURITY.
- 16) ECONOMICS STAGNATION + RISING UNEMPLOYMENT = STAGFLATION.
- 17) WATERGATE INVESTIGATORS FOUND INDISPUTABLE EVIDENCE AGAINST THE PRESIDENT WHEN A TAPE REVEALED THAT NIXON HAD ORDERED THE CIA TO STOP THE FBI INVESTIGATION.
- 18) PRESIDENT FORD'S APPROVAL RATING PLUNGED WHEN HE PARDONED RICHARD NIXON.
- 19) THE 1978 PANAMA CANAL TREATIES TRANSFERRED CONTROL OF THE PANAMA CANAL FROM THE U.S. TO PANAMA.
- 20) WATERGATE BURGLAR AND EX-CIA OFFICIAL- JAMES McCORD.
- 21) COUNSEL WHO LEVELED ALLEGATIONS AGAINST NIXON - JOHN DEAN
- 22) ARCHIBALD COX WAS SPECIAL PROSECUTOR WHO TOOK NIXON TO COURT TO FORCE HIM TO TURN OVER THE TAPES.
- 23) GERALD FORD BECAME NIXON'S VICE PRESIDENT AFTER SPIRO AGNEW RESIGNED.
- 24) JOHN MITCHELL WAS ACCUSED OF ORDERING THE WATERGATE BREAK-INS.
- 25) JOHN. J SIRICA WAS THE JUDGE HEARING THE CASE OF THE WATERGATE BURGLARS.
- 26) ALEXANDER BUTTERFIELD TESTIFIED THAT NIXON HAD ORDERED A TAPING SYSTEM INSTALLED IN THE WHITE HOUSE.
- 27) RICHARD NIXON ASKED THE CIA TO STOP THE FBI FROM INQUIRING INTO THE SOURCE OF THE MONEY PAID TO THE WATERGATE BURGLARS.
- 28) SAM J. ERVIN CHAIRED THE SENATE'S SELECT COMMITTEE ON PRESIDENTIAL CAMPAIGN ACTIVITIES.
- 29) BOB WOODWARD WAS A WASHINGTON POST REPORTER WHO BROKE THE WATERGATE STORY.
